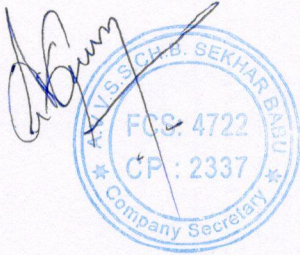
The Company issued 19,29,800 partly paid-up equity shares on Rights Issue basis. The Company has collected an amount of Rs.2.50 per equity share on the face value of Rs.10/- each share (on Application), Rs.5 per equity share on First Call and Rs.2.5 per equity share on Second & Final Call.

The Company had forfeited 1,13,154 partly paid up equity shares consisting of 79,435 shares on which an amount of Rs.7.5/- is paid up 33,719 shares on which an amount of Rs.2.5/- is paid up vide its board resolution dated 27.05.2024.

During the quarter the company filed corporate action forms to both the depositories for forfeiture out of which the company has received confirmation letter for 25,096 partly paid up shares and corporate action is under process for remaining shares.

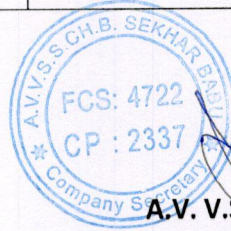

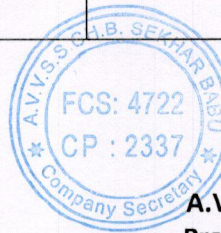
